Compared to other addictive disorders, problem gambling (including Gambling Disorder) is associated with a high rate of suicide attempts. This session will offer a broad overview of problem gambling and its impacts. It will include an overview of gambling, recreational gambling, problem gambling, and Gambling Disorder. Information on how to pursue Gambling Counselor Certification will also be provided in the session.
